THE VISION 2010 STRATEGIC PLAN ADOPTED

The Vision 2010 Strategic Plan was adopted by the Boards of both the Tyler Area Chamber of Commerce and the Tyler Economic Development Council in March. Mike Thomas, who chaired the Vision Task Force, presented the report at the meetings which identified the following priorities:

The strategic planning process was facilitated by TIP Strategies, Inc., Austin, TX and was sponsored by the Tyler Area Chamber of Commerce and Tyler Economic Development Council.

Task Force meetings were held last fall and participating organizations were surveyed in January. They included the Tyler Area Chamber of Commerce, Tyler Economic Development Council, Tyler Metro Chamber of Commerce, Hispanic Business Forum, and local elected officials in Smith County.

The priorities listed were designed to address a variety of community issues from a "business perspective" and will be monitored over the next five to ten years for progress and completion. Copies of the plan are available at the TEDC and Chamber offices.



PARTNERS IN EDUCATION AWARDS PRESENTED

One of the goals and objectives of the Chamber is to support quality education and one way we do this is working closer with TISD and other educational institutions on programs such as Partners in Education and Teacher of the Year awards. Partners in Education brings the business community together with the educational community to work on a common goal: educating the workforce of tomorrow.

Each year the Chamber in conjunction with TISD presents four Partners in Education awards to those businesses, organizations and individuals who have exhibited outstanding achievement in partnering with the TISD elementary, middle and high schools. At a banquet on April 12th Chamber Chairman Jeff Austin III presented this year's awards to "Rookie of the Year"-Carrier Air Conditioning, "Excellence in Corporate Service" to Tyler Rotary Club, "Most Valuable Partner" to Christ Episcopal Church and "Someone Special" to Dr. Paul Andrews.

TYLER AIRPORT USES GRANT TO EDUCATE CITIZENS

East Texans can book flights directly from Tyler Pounds Regional Airport to almost anywhere in the world.

This concept seems simple enough, but Airport Manager Davis Dickson said there are still people who don't realize they can conveniently book flights from Tyler's airport to their destination.

"You'd be surprised how many people think they have to book their flight from Tyler to Dallas or Houston, and then book their flight from those hubs to their final destination. That makes it a two-step process. It's often less expensive to make it a one-step process. Simply book the flight directly from Tyler to the final destination," Dickson said.

The connection is still in Dallas or Houston, but the savings come from booking the flight once – from Tyler to the destination.

Even when fares from Dallas or Houston are comparable, Dickson said parking at Tyler Pounds Regional Airport is less expensive and more convenient than parking at either of the larger airports. Additionally, lines for security and baggage claim are much shorter and less of a hassle.

To educate the public about the benefits of flying from Tyler's airport, the City has used a U.S. Department of Transportation grant awarded last year to develop commercials, advertisements and billboards. The commercials recently began airing on local TV stations. Advertisements have already appeared in newspapers across the region and radio commercials will begin airing soon. A billboard on U.S. 69 communicates the same message – that the Tyler airport is a gateway to the world.

"We just want people to be aware of what a resource their airport actually is and encourage them to use it," Dickson said.

Tyler Pounds Regional Airport offers frequent daily service to DFW through American Eagle and George Bush Intercontinental Airport in Houston through Continental Connection.
